INSTRUCTIONS

HOW TO COMPLETE THE FORM

- 1. Sections 1, 2 and 6 must be completed by all applicants.
- 2. Sections 3 and 4 are to be completed where applicable.
- 3. Section 7 is to be completed by the Parent or Legal Guardian of an applicant under age 16.
- 4. Section 8 is to be completed by an applicant age 16 and over.
- 5. Section 9 is to be completed by the recommender.
- 6. Section 10 is to be completed if your passport has been lost or stolen.

DOCUMENTS TO BE PRODUCED

FOR PERSONS UNDER AGE 16 AND RETIREES

- 1. Completed Application Form
- 2. Two (2) passport sized photos
- 3. Birth Certificate of applicant
- 4. Certificate of Citizenship (*if applicable*)
- 5. Old passport (*if applicable*)
- 6. Any other document as may be required
- 7. £75 Application Fee

FOR PERSONS AGE 16 AND OVER

- 1. Completed Application Form
- 2. Two (2) passport sized photos
- 3. Birth Certificate of applicant (Original or Certified Copy)
- 4. Certificate of Citizenship (if applicable)
- 5. Old passport (if applicable)
- 6. Marriage Certificate (*if applicant wishes to carry the surname of the spouse*)
- 7. Decree Absolute (*if applicant wishes to revert to maiden name*)
- 8. £125 Application

Damaged passports – Applicants who wish to replace a damaged passport must submit a letter to the Permanent Secretary, Ministry of National Security stating the conditions under which the passport was damaged.

Lost or stolen Passports – An affidavit providing details of the passport and the conditions under which the passport was lost or stolen (whether valid or expired) must be submitted to the Passport Office at least one month prior to an application for a new passport.

Photographs – Two copies of a recent photograph of the applicant must be included with the application. These photographs should be taken full face, without a hat on a neutral solid background. <u>As per ICAO stipulation, kindly</u> ensure that teeth are not visible in the

<u>NB</u>: FOR THE PROPER PROCESSING OF THE NEW MACHINE READABLE PASSPORTS, THE SIGNATURE AT THE TOP OF PAGE 2 MUST <u>NOT</u> TOUCH THE LINES OF THE BOX.

Recommendation - Section 9 should be completed by the person verifying the declaration of the applicant. The recommender should be a**Justice of the Peace**, **Notary Public**, **Minister of Religion**, **Medical or Legal Practitioner**, **Senior Civil Servant**, **Senior Bank Official**, or any person of **similar standing who isPERSONALLYACQUAINTED with the applicant**.

Nationals of St. Kitts and Nevis resident in Europe are required to submit their appications to: **The St.Kitts and Nevis High Commission**, **10 Kensington Court**, **London**, **W8 5DL**, England

The High Commission does not recommend that applicants send cash in the mail. For mail-in passport applications, a Postal Order or other Draft in favour of the *High Commission for St Kitts & Nevis* in the relevant amount is recommended for settlement of the above mentioned fees.
